## PHILOSOPHY

Titus Mountain Racer Coaching Program is a season-long program (10 training sessions) for participants age 6-18 that is designed to promote and support the development of fundamental alpine skiing skills. The training program is based upon the USSA Alpine Training System and Skills Quest program. The program goal is to create good skiers through racing. Emphasis is placed on having fun and socializing with friends while developing new skills and nurturing a lifelong enthusiasm for the sport.

## PREREQUISITES

- Pre-registration is mandatory. Registration for 2019 will be open through 1/5/19.
- Participants must, at a minimum, be able to load & unload from a chairlift unassisted; and safely navigate down Intermediate ("blue square") terrain.

## 2019 CALENDAR

- Program commences 1/5/19 & runs every Saturday morning through 3/9/19 (10 weeks).
- Each day's session begins @ 9:30am sharp, and concludes with the participants of the program being released at Noon to parents/guardians to compete in the CHALLENGE Race.

## COST

2019 Program Fee is \$330.00; Program Fee does include Challenge Race Series; Program Fee does not include lift tickets. See Race Program Fee Structure 2019 for applicable early pay and additional child discounts, plus ages 14-17 Coaching.
